

Aim and scope:

The *Annual Report of the International Research Institute for Advanced Buddhology at Soka University* (ARIRIAB), published annually since 1997, contains papers on a wide range of Buddhist studies, from philological research on Buddhist texts and manuscripts in various languages to studies on Buddhist art and archaeological finds. Also, by publishing and introducing newly-discovered manuscripts and artefacts, we aim to make them available to a wider public so as to foster further research.

ARIRIAB is issued once a year in March by the International Research Institute for Advanced Buddhology, Soka University. This is published with the support of Soka University, Tokyo, Japan.

Publication Ethics and Malpractice Statement

The ethics statements for the *Annual Report of the International Research Institute for Advanced Buddhology* (ARIRIAB) are based on the guidelines of Committee on Publication Ethics (COPE; <https://publicationethics.org>) and on the ELSEVIER Publishing Ethics Resource Kit (<https://www.elsevier.com/editors/perk>).

Duties of the editors-in-chief:

The editors-in-chief of the ARIRIAB are responsible for deciding which of the articles submitted to the journal should be published. The editors-in-chief should ensure that the research material they publish conforms to internationally accepted ethical guidelines. The editors must not disclose any information about a submitted manuscript to anyone other than the corresponding author, reviewers and other editorial advisers. The editors evaluate manuscripts for their intellectual content without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, or political philosophy of the authors. Unpublished materials disclosed in a submitted manuscript must not be used in an editor's own research without written consent of the author.

Duties of the authors:

The authors submitting manuscripts to the ARIRIAB must ensure that:

1. The work submitted in the manuscript is original and has not been published elsewhere and is not presently under consideration of publication by any other journal.
2. The material in the manuscript has been acquired according to modern ethical standards.
3. The article does not contain material copied from anyone else without their written permission.
4. The author has the approval of all other listed authors for the submission and publication of all versions of the manuscript.
5. All material which derives from prior work, including from the same authors, is properly attributed to the prior publication by proper citation.
6. Proper acknowledgment of the work of others must always be given. Authors should cite publications which have been influential in determining the nature of the reported work.
7. An author should not in general publish manuscripts describing essentially the same research in more than one journal or primary publication in the same language.

Duties of the reviewers:

1. Any manuscripts received for review must be treated as confidential documents.
2. Reviews should be conducted objectively. Referees should express their views clearly with supporting arguments.
3. Reviewers should identify relevant published work which has not been cited by the authors. A reviewer should also call to the editor's attention any substantial similarity or overlap between the manuscript under consideration and any other published paper of which they have personal knowledge.
4. Reviewers should not consider manuscripts in which they have conflicts of interest.
